

LEGAL NOTICE

Sealed Proposals endorsed "*The City of Milford Jim Terrell Park Kayak Launch*" will be received at the offices of the City of Milford, 745 Center Street, Suite 200, Milford, Ohio 45150 until **10:30 A.M. Local Time on Tuesday, February 6, 2024**, and then publicly opened and read aloud.

A non-mandatory pre-bid meeting will take place on Tuesday, January 30, 2024 at 10AM. The meeting will be held at the City of Milford, 745 Center Street, Suite 200, Milford, Ohio 45150. After the meeting we will walk the site, weather permitting.

The Kayak Launch will consist of excavation for a stained concrete ramp with access to the Little Miami River. Stone stairs will be constructed along the ramp down to the water's edge. Additionally, the ramp will have a wooden kayak launch along the side of the concrete. The City of Milford also desires to repair/replace the existing asphalt within the Jim Terrell Park limits.

Each bidder is required to furnish with the proposal a Bid Guaranty and Contract Performance Bond in accordance with Section 153.54 through 153.571 of the Ohio Revised Code. Bid security furnished in Bond form shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. The owner intends and requires that this project be completed no later than 90 days from the date of the Notice to Proceed. Work shall be substantially completed and acceptable by **May 17, 2024**.
